What is the Greater Victoria Sport Tourism Commission (GVSTC)?

The GVSTC, a non-profit organization affiliated with Destination Greater Victoria, is committed to enhancing the caliber and number of sport tourism events held in Greater Victoria. Our main objective is to secure sport events that generate substantial overnight stays in paid accommodation during the usual off-peak months (January to April and October to early December).

What is sport tourism?

Sport tourism is when people travel to another place to watch or participate in sport events. This can include athletes, teams, and people who want to watch the events. When these groups come to visit, they help our local economy by spending money at hotels, restaurants, and other places.

Sport tourism also contributes to the development of local sport by using local facilities and resources, exposing people to new sports and activities, and generating revenue that can be invested in sports infrastructure and programs.

Who benefits from our sport membership?

Membership in the GVSTC is advantageous for any organization with a stake in local sports or sports tourism. Our membership comprises various entities, including local municipalities and districts, hoteliers, event service providers, sports organizations, restaurants, retail and tour groups, and more!

What are our services?

Our Sport Tourism Express program assists event organizers with services such as securing hotel accommodations, finding suitable restaurant and banquet venues, and creating athlete experience itineraries.
