

DESTINATION GREATER VICTORIA – NORTHWEST DEUCE DAYS PHOTO CONTEST

OFFICIAL RULES & REGULATIONS

Win one prize pack of Deuce Days swag containing a t-shirt (men’s, women’s, or youth), a ball cap, as well as a \$150 Gift Card provided by Destination Greater Victoria. The contest will begin at 8 am PDT on July 14, 2022 and close on July 20, 2022 at 4 pm PDT. One winner will be selected at random from all eligible entries. Winners will be notified via direct or private message, depending on how they have entered.

1. DATES

The Contest will begin on July 14, 2022 at 08:00 PDT. The Contest will end at 16:00 PDT on July 20, 2022 (the “Closing Date”). The winner will be selected at random from all eligible entries. The winner will be notified via Instagram direct message, Facebook private message, or Twitter direct message depending on how they have entered.

2. ELIGIBILITY

The contest is open to any Canadian or American resident (excluding Quebec and Puerto Rico) over the age of 18 years who enters the contest by tagging #NWDeuceDays in related Greater Victoria Northwest Deuce Days vintage car posts on social media (Facebook, Twitter, and Instagram).
